It has been the committee's experience that many folks with limited mobility have resources to assist in using this chair. Please take into consideration that this chair is a machine that needs minor upkeep. It does need regular tightening of belts and charging of batteries. The chair does not come with a trailer to transport. Some of our successful recipients have family or friends that assist with simple maintenance. The warranty is very clear, the recipients cannot repair or move any components on their own. It will void your warranty. All warranty information is given at the time of the delivery of the chair. All warranty is through the manufacturer, not NWSC.

If chosen, the recipient is responsible for transportation of the chair from the location of our next fundraiser. That location will be determined at a date in the near future. A release of liability towards NWSC waiver must be signed at the time of delivery. All warranty communication is a partnership between you and Trac Fab.
